1. Improving clinical skills for recognizing and responding to perinatal mood and anxiety disorders, trauma, grief, and co-occurring conditions.
2. Supporting provider mental health and reducing burnout among those who work in high-stress, emotionally demanding care settings.



Learning Objectives

1. Identify perinatal mood and anxiety disorders, trauma responses, and grief-related distress using trauma-informed, evidence-based approaches.
2. Apply practical assessment and referral strategies consistent with scope of practice and current legislative expectations.
3. Implement targeted interventions addressing perinatal anxiety, grief and loss, eating disorders and body dysmorphia, and substance use disorders.
4. Recognize and mitigate the effects of secondary trauma and compassion fatigue in professional settings.
5. Integrate evidence-supported resilience strategies to sustain long-term engagement in perinatal care.
